#### Section 4. First aid measures

## **Section 5. Fire-fighting measures**

#### Flammability of the product

: Extremely flammable. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of a subsequent explosion. Gas may accumulate in low or confined areas or travel a considerable distance to a source of ignition and flash back, causing fire or explosion. Bursting aerosol containers may be propelled from a fire at high speed. Runoff to sewer may create fire or explosion hazard.

#### **Extinguishing media**

### Section 6. Accidental release measures

#### **Personal precautions**

: In the case of aerosols being ruptured, care should be taken due to the rapid escape of the pressurized contents and propellant. If a large number of containers are ruptured, treat as a bulk material spillage according to the instructions in the clean-up section. Shut off all ignition sources. No flares, smoking or flames in hazard area. Do not breathe vapor or mist. Provide adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Put on appropriate personal protective equipment (see Section 8).

#### **Environmental precautions**

#### Methods for cleaning up

**Small spill**

#### Large spill

: Immediately contact emergency personnel. Stop leak if without risk. Prevent entry into sewers, water courses, basements or confined areas. Use spark-proof tools and explosion-proof equipment. Dispose of via a licensed waste disposal contractor. Contaminated absorbent material may pose the same hazard as the spilled product. ## Section 7. Handling and storage

#### Handling

: Put on appropriate personal protective equipment (see Section 8). Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking and smoking. Pressurized container: protect from sunlight and do not expose to temperatures exceeding 50°C. Do not pierce or burn, even after use. Do not get in eyes or on skin or clothing. Do not breathe vapor or mist. Do not ingest. Avoid breathing gas. Use only with adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Use explosion-proof electrical (ventilating, lighting and material handling) equipment. Use non-sparking tools. Empty containers retain product residue and can be hazardous. Keep away from heat, sparks and flame.

#### **Storage**


